What is covered through our insurance package?

Liability

The (professional) team must take out a civil liability insurance policy for all damages that the team members may cause in the course of their professional activities, taking account of the insurance policy previously concluded by the person in question and/or by his national federation.

Disability

In case total and permanent disability of the rider due to an accident (round the clock) payment of **250.000 €** to the rider (in accordance with joint agreement art. 23.2)

Decease

In case of death of the rider, payment of **100.000 €** to the interested parties named by the rider. Some risk activities may be excluded (see joint agreement) (in accordance with joint agreement Art. 23.1)

Travel Health Insurance

Hospitalization expenses for an amount of € 100'000 per disaster (only travel insurance, not for rider's/staff's residence, only ABROAD)

Repatriation

Repatriation expenses of the rider and staff for medical reasons or in case of decease during professional trips

SVL Medical Secure Basic Plan

Covers treatments (hospitalization of rider/staff in the residence country).

Extension Travel Health Insurance for Country of Residence

You can extend the Travel Health Insurance with cover for job related accidents in the country of residence (hospitalization)

Pregnancy - Maternity

We cover cost's being for investigations in connection with or complications arising from a pregnancy but excluding discovery of. € 50,000 maximum limit for medical costs any one rider.
